# **GIFT SURCHARGE IMPLEMENTATION DETAILS**

Administrative surcharge is assessed on expenditures as incurred. The surcharge process applies a specific percent of surcharge to expenses incurred according to fund type and specific account codes. Administrative surcharge will be charged to a restricted gift fund according to the following table:

The surcharge amount will be debited on each individual fund as follows:

- 594 Tuition & Equipment (there should not be activity on this account code)
- 595 Faculty Salaries with Benefits (13.2%)
- 596 Graduate Salaries without Benefits (10%)
- 597 Research Salaries with Benefits (33%)
- 598 All Other Research (25%)

### Fund Type H2 - Non-Research Gifts

The H2 fund type will be charged a 10% surcharge based upon expenses as they are incurred, regardless of account code. The surcharge will be debited to each individual fund to account code 599 Non-Research (10%).
